

Skip Logic

The purpose of this document is to identify skip logic that occurs within the submission system for both LEA and School Forms. Throughout the CRDC survey, there are 'Indicator' questions commonly requiring a yes / no response. A "Yes" answer to an indicator lets the system know that certain questions should be presented or not presented to the data submitter. A "No" answer to an indicator can either mean certain questions will be filled with a "0" or "NA." The submission system will skip related questions and populate these questions with 'NA' (not applicable).

Skip logic is also triggered when a "0" is entered. For example, if a school indicates that no students are enrolled in Advanced Placement (AP) Math, then the system will skip over the question asking for counts of students in AP Mathematics based on demographic subgroups.

Additionally, some questions within the CRDC are only applicable to high schools, while others apply to a certain range of grades only.

When to Report Zero (0) and When to Use Blanks (i.e., Null Values)

Zeroes represent an actual count or number for fields that are applicable to a given school or LEA. Report a zero ("0") only if the LEA has collected the information and the amount to report for that field is zero. Do not report a "0" for data not collected. Leave a field blank if the LEA does not collect data for that field, if the amount asked is unknown, or if the question does not apply to the LEA.

Not Applicable (NA) And Zero (0) Fills in Tables

The online tool remembers information that has been entered in other tables and modules and uses that information to fill related tables with either a Not Applicable (NA) code or zero (0) where appropriate. For example, if it is reported that a school does not have any female students who are EL, then other tables that ask for counts of female students who are EL will be automatically filled with a zero. - DISC-4: Preschool Corporal Punishment

If DISC-9: Corporal Punishment Indicator = "No" Fill in cells with "0" in the following:

- DISC-10: Instances of Corporal Punishment
- DISC-11: Discipline of Students without Disabilities Corporal Punishment
- DISC-12: Discipline of Students with Disabilities Corporal Punishment

Frequently Asked Questions

What do I do if we are getting warnings for entering zeros (i.e., skipped field warnings)?

The warnings you are encountering will not block your certification, but PSC recommends clearing all errors and warnings before certifying. Please note you do not need to remove the zeros, by default the warning message is explaining that upon certification they will default to NA. However, if you would like to clear the

warnings, you will need to:

- 1. Change the indicator question from "No" to "Yes;"
- 2. Return to table with warnings and manually remove the zeros; and
- 3. Change the indicator question from "Yes" back to "No."

Note if you are comfortable with submitting flat files, you can upload a CSV file replacing the zeros with a NS value as an alternative. This is the recommended method for advanced users responsible for large districts.
